PLEASE NOTE:

- All references to the Poughkeepsie Spackenkill NY 5ESS switch are associated with CLLI code PGHKNYSPDS0 and will not be repeated throughout this notice.
- All references to the Poughkeepsie NY Packet End Office (PEO) are associated with CLLI code PGHKNYSHPS0 and will not be repeated throughout this notice.

Description of the Planned Network Change(s):

The Verizon Poughkeepsie Spackenkill NY 5ESS switch, located at 35 Stuart Drive, Poughkeepsie, NY 12603, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Poughkeepsie NY PEO, located at 20 South Hamilton Street, Poughkeepsie, NY 12601. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Poughkeepsie NY PEO switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Poughkeepsie Spackenkill NY 5ESS switch will be required to reposition the codes to the Poughkeepsie NY PEO switch.

All ASRs for the Poughkeepsie NY PEO switch must be received no later than February 15, 2022 in order to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Poughkeepsie Spackenkill NY 5ESS switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Poughkeepsie Spackenkill NY 5ESS switch (on or after April 1, 2022). This will serve to guide interconnect re-routes of traffic for the four (4) native codes currently served by the Poughkeepsie Spackenkill NY 5ESS switch to reflect the Poughkeepsie NY PEO switch as the new home switch. All ASRs for the Poughkeepsie NY PEO switch must carry the project code of PGHKNYSPDS0.
