PLEASE NOTE:

- All references to the Wall Township/Manasquan NJ DMS 100 switch are associated with CLI code MNSQNJ01DS5 and will not be repeated throughout this notice.
- All references to the New Brunswick NJ CS2K switch are associated with CLI code NBWKNJNBPS1 and will not be repeated throughout this notice.

**Description of the Planned Network Change(s):**

The Verizon Wall Township/Manasquan DMS100 switch located at 1223 Church Street, Manasquan, NJ 08736 will be decommissioned and replaced by the Verizon New Brunswick CS2K switch located at 18-24 Paterson Street, New Brunswick, NJ 08901. After all traffic served by the Wall Township/Manasquan DMS100 switch is migrated to the New Brunswick CS2K switch, the Wall Township/Manasquan DMS100 switch will be decommissioned (retired). Network trunks will be interconnected through the New Brunswick CS2K switch. Once these changes are completed, the New Brunswick CS2K switch for all three (3) NPA NXX codes that are currently native to the Wall Township/Manasquan DMS100 switch will be reflected in the LERG. Traffic to be migrated to the New Brunswick CS2K switch includes, but is not limited to, Inter-LATA access traffic (including Feature Group B and D traffic), Intra-LATA traffic, and local traffic.

**Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):**

All carriers, including competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless and paging carriers, will need to submit new trunk groups built to the New Brunswick CS2K switch or have existing trunk groups to that switch augmented. Prior to decommissioning of the Wall Township/Manasquan DMS100 switch on or after **December 11, 2017**, LERG change effective dates will be posted. This will serve to guide interconnect re-routes of traffic for the three (3) native codes currently served by the Wall Township/Manasquan DMS100 switch to reflect the New Brunswick CS2K switch as the new home switch.

All ASRs for the New Brunswick CS2K switch must be received no later than **November 13, 2017**, in order to provide sufficient time to provision those facilities prior to the migration of the traffic described above. All trunks to the New Brunswick switch must be in place before the retirement of the Wall Township/Manasquan DMS100 switch, which will occur on or after **December 11, 2017**. All ASRs for the New Brunswick switch must include the project code of **MNSQNJ01RP0**.
