**Description of the Planned Network Change(s):**

Verizon intends to retire certain copper facilities in the Brandon, Florida central office area at the locations listed on the attached Exhibit A and to provide services over a fiber network infrastructure. Verizon has deployed its FiOS fiber-to-the-home network in the areas identified in Exhibit A.

**Description of reasonably foreseeable impact(s) of the planned change(s):**

After the retirement of copper facilities, Verizon will: (1) no longer be required to offer UNEs or other services over copper facilities; and (2) remove or cease maintaining the copper facilities. However, to the extent required by applicable agreements and federal law, Verizon will offer to requesting carriers a 64 Kbps voice grade channel over fiber loops that have been deployed where copper loops were retired.
