SS7 services currently provided by the VZ PA Altoona (ALNAPAAL77W) STP and the VZ PA DuBois (DUBSPADU77W) STP will, after completion of the network changes, be provided via the VZ PA Pittsburgh (PITBPADT77W) STP and the VZ PA Oakland (PITBAPAOK77W) STP. The SS7 links originating from the VZ PA end offices listed below will be rehomed from the VZ PA Altoona (ALNAPAAL77W) STP and the VZ PA DuBois (DUBSPADU77W) STP to the VZ PA Pittsburgh (PITBPADT77W) STP and the VZ PA Oakland (PITBAPAOK77W) STP.
