## PLEASE NOTE:

- All references to the Philadelphia Market PA CS2K switch are associated with CLLI code PHLAPAMKPS1 and will not be repeated throughout this notice.
- All references to the Philadelphia Market PA C20 switch are associated with CLLI code PHLAPAMKPS2 and will not be repeated throughout this notice.

# **Description of the Planned Network Change(s):**

The Verizon Philadelphia Market PA CS2K switch located at 900 Race St., Philadelphia, PA 19108, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Philadelphia Market PA C20 switch located at 900 Race St., Philadelphia, PA 19108. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

## **Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):**

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Philadelphia Market PA C20 switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Philadelphia Market PA CS2K switch will be required to reposition the codes to the Philadelphia Market PA C20 switch.

All ASRs for the Philadelphia Market PA C20 switch must be received no later than May 10, 2020 in order to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Philadelphia Market PA CS2K switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Philadelphia Market PA CS2K switch (**on or after June 10, 2020**). This will serve to guide interconnect re-routes of traffic for the native codes on the eight (8) end offices currently served by the Philadelphia Market PA CS2K switch to reflect the Philadelphia Market PA C20 switch as the new home switch. All ASRs for the Philadelphia Market PA C20 switch must carry the project code of **PHLAPAMKPS2.**
