PLEASE NOTE:

- All references to the Mechanicsville VA 5E switch are associated with CLLI code MCHVVAMVDS0 and will not be repeated throughout the notice.
- All references to the Grace Street VA CS2K switch are associated with CLLI code RCMDVAGRPS1 and will not be repeated throughout this letter.

Description of the Planned Network Change(s):

The Verizon Mechanicsville VA 5E switch, located 8190 Meadowbridge Road, Mechanicsville, VA 23116, will be retired and removed from the Verizon network after all traffic served by this switch is migrated to the Verizon Grace Street VA CS2K switch, located at 703 E. Grace Street, Richmond, VA 23219. All traffic to be migrated to the Grace Street VA CS2K switch includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC IXC), wireless and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

All carriers, including competitive local exchange carriers (CLECs), Interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers, will need to provision new trunk groups to support direct end office trunking to the Grace Street VA CS2K switch or have existing trunk groups to that switch augmented.

All ASRs for the Grace Street VA CS2K switch must be received no later than **May 21, 2025**, to provide sufficient time to migrate the traffic described above. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Mechanicsville VA 5E switch (**on or after July 2, 2025**). This will serve to guide interconnect re-routes of traffic for the NPA codes currently served by the Mechanicsville VA 5E switch to reflect the Grace Street VA CS2K switch as the new home switch. All trunks to the Grace Street VA CS2K switch must be in place prior to the decommissioning of the Mechanicsville VA 5E switch.
