Description of the Planned Network Change(s):

Verizon intends to retire a small number of copper facilities in the East 79th St. and East 97th St., New York central offices serving the locations listed on the attached Exhibit A and to provide services over a fiber network infrastructure. Verizon has deployed its fiber-to-the-home network in the areas identified in Exhibit A.

Description of reasonably foreseeable impact(s) of the planned change(s):

After the retirement of the copper facilities, Verizon will: (1) no longer offer services over copper facilities; and (2) cease maintaining the copper facilities. However, to the extent required by applicable agreements and federal law, Verizon will offer to requesting carriers a 64 Kbps voice-grade channel over fiber.
