PLEASE NOTE:

- All references to the Kirklyn PA EWSD switch are associated with CLLI code KRLNPAKLDS0 and will not be repeated throughout this notice.
- All references to the Market Street PA CS2K switch are associated with CLLI code PHLAPAMKPS1 and will not be repeated throughout this notice.

## **Description of the Planned Network Change(s):**

The Verizon Kirklyn EWSD switch located at 9225 West Chester Pike, Kirklyn PA 19082, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Market Street CS2K switch located at 900 Race Street, Philadelphia PA 19108. Traffic to be migrated to the Market Street CS2K switch includes, but is not limited to, Inter-LATA access traffic (including Feature Group B and D traffic), Intra-LATA traffic, and local traffic.

## **Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):**

All carriers, including competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless, and paging carriers, will need to submit new trunk groups built to the Market Street CS2K switch or have existing trunk groups to that switch augmented. Prior to decommissioning of the Kirklyn EWSD switch on or after **September 15**, **2017**, LERG change effective dates will be posted. This will serve to guide interconnect re-routes of traffic for the eight (8) native codes currently served by the Kirklyn EWSD switch to reflect the Market Street CS2K switch as the new home switch.

All ASRs for the Market Street CS2K switch must be received no later than **August 24, 2017**, in order to provide sufficient time to provision those facilities prior to the migration of the traffic described above. All trunks to the Market Street CS2K switch must be in place before the retirement of the Kirklyn EWSD switch, which will occur on or after **September 15, 2017**. All ASRs for the Market Street CS2K switch must include the project code of **KRLNPAKLRP1**.
