# PLEASE NOTE:

- All references to the Market VoIP G0T Tandem switch are associated with CLLI code PHLAPAMKG0T and will not be repeated throughout this notice.
- All references to the Market 90T DMS200 Tandem switch are associated with CLLI code PHLAPAMK90T and will not be repeated throughout this notice.

## **Description of the Planned Network Change(s):**

The Verizon Market VoIP G0T Tandem switch located at 900 Race Street, Philadelphia, PA 19108, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Market 90T DMS200 Tandem switch located at 900 Race St, Philadelphia, PA 19108. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

# **Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):**

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers, will need to secure new trunk groups built to the Market 90T DMS200 Tandem switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Market VoIP G0T Tandem switch will be required to reposition the codes to the Market 90T DMS200 Tandem switch.

All ASRs for the Market 90T DMS200 Tandem switch must be received no later than September 25, 2018 in order to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Market VoIP GOT Tandem switch, prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Market VoIP GOT Tandem switch (**on or after November 12, 2018**). This will serve to guide interconnect re-routes of traffic for the ten (10) end offices currently served by the Market VoIP GOT Tandem switch to reflect the Market 90T DMS200 Tandem switch as the new home switch. All ASRs for the Market 90T DSM200 Tandem switch must carry the project code of **PHLAPAMKG0T**.
