## **Description of the Planned Network Change(s):**

The Verizon Brookside DCO (Digital Central Office) remote office switch (BKSDPAXBRS0) located at 12535 RT 287, HWY 184, Brookside, PA, 17963, will be retired and removed from the network after all traffic served by this switch is migrated to the alternative switch described below. All traffic currently handled by the Brookside DCO remote office switch (BKSDPAXBRS0) will be migrated to the Selinsgrove DMS (Digital Multiplex System) 100 switch (SLGVPAXSDS0) located at 21 S. Market Street, Selinsgrove, PA, 17870. All traffic will be migrated to the Selinsgrove DMS 100 switch (SLGVPAXSDS0), including, but not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

## **Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):**

Competitive local exchange carriers, (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers, will need to secure new trunk groups built to the Selinsgrove DMS 100 switch (SLGVPAXSDS0) or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Brookside DCO remote office switch (BKSDPAXBRSM/RS0) will be required to reposition the codes to the Selinsgrove DMS 100 switch (SLGVPAXSDS0).

All ASRs for the Selinsgrove DMS 100 switch (SLGVPAXSDS0) must be received no later than November 16, 2016, in order to provide sufficient time to migrate the traffic described above. All traffic must be moved by December 7, 2016. All ASRs for the Selinsgrove DMS 100 switch (SLGVPAXSDS0) must carry the project code of BKSDPAXBRS1.
