Subject: Verizon Partner Solutions Industry Letter: Boston Franklin Street (BSTNMAFRDS2), MA 5ESS Switch Retirement

PLEASE NOTE:

- All references to the Boston Franklin Street, MA 5ESS switch are associated with CLLI code **BSTNMAFRDS2** and will not be repeated throughout this letter.
- •All references to the Newton, MA C20 switch are associated with

CLLI code NWTNMAWAPS1 and will not be repeated throughout this letter.

As set out in the Verizon New England Inc. Public Notice of Network Change Under Rule 51.329(a), dated March 22, 2024, the Boston Franklin Street, MA 5ESS switch will be retired and removed from the Verizon network on or after January 2, 2025, as part of ongoing efforts to modernize the network.

General Information: The Exchange Codes (NXXs) in Numbering Plan Area (NPA) 617 currently residing in the Boston Franklin Street, MA 5ESS switch (see list in Table B below) will be moved to the Newton, MA C20 switch (see details in Table A below).

The native NPA NXXs belonging to the Boston Franklin Street, MA 5ESS switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Newton, MA C20 switch. This will occur on or after January 2, 2025.

Network Changes and Trunk Rearrangements:

The Newton, MA C20 switch will be the recipient office of traffic migrated from the Boston Franklin Street, MA 5ESS switch. Traffic bound for the codes listed in Table B will be delivered via the Newton, MA Tandem (NWTNMAWA01T intra-lata SHA / NWTNMAWA01T inter-lata FG Access SHA).

After all traffic is migrated off of the Boston Franklin Street, MA 5ESS switch, it will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers, and paging carriers will need to secure new trunk groups built to the Newton, MA C20 switch or have existing trunk groups to that switch augmented.

Carriers that have direct end office trunks (DEOT) with access connectivity in the Boston Franklin Street, MA 5ESS switch will be required to reposition the codes to the Newton, MA C20 switch.

All ASRs for the Newton, MA C20 switch must be received no later than November 15, 2024 to provide sufficient time to migrate the traffic described above. All traffic must be moved by January 2, 2025. All ASRs for the Newton, MA C20 switch

must carry the project code of BSTNMAFRDS2.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Boston Franklin Street, MA 5ESS switch.
