Subject : Verizon Partner Solutions Industry Letter: Bridge Street NY 5E Switch Retirement

PLEASE NOTE:

- All references to the Bridge Street NY 5E switch are associated with CLLI code NYCKNYBRDS0 and will not be repeated throughout this letter.
- All references to the Williamsburg NY C20 switch are associated with CLLI code NYCKNYWMPS1 and will not be repeated throughout this letter.

As set out in the Verizon New York Inc. Public Notice of Network Change Under Rule 51.329(a), dated June 21, 2024, on or after January 2, 2025, the Bridge Street NY 5E switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

General Information: The Exchange Codes (NXXs) in Numbering Plan Areas (NPAs) 718 and 347 currently residing in the Bridge Street NY 5E switch (see list in Table B below) will be moved to the Williamsburg NY C20 switch (see details in Table A below).

The native NPA NXXs belonging to the Bridge Street NY 5E switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Williamsburg NY C20 switch. This will occur on or after January 2, 2025.

Network Changes and Trunk Rearrangements:

The Williamsburg NY C20 switch will be the recipient office of traffic migrated from the Bridge Street NY 5E switch. Traffic bound for the codes listed in Table B will be delivered via the Williamsburg NY 24T tandem local and Williamsburg NY 25T tandem LD FG (NYCKNYWM24T intra-lata SHA / NYCKNYWM25T inter-lata FG Access SHA).

After all traffic is migrated off the Bridge Street NY 5E switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers, and paging carriers will need to secure new trunk groups built to the Williamsburg NY C20 switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the Bridge Street NY 5E switch will be required to reposition the codes to the Williamsburg NY C20 switch.

All ASRs for the Williamsburg NY C20 switch must be received no later than November 1, 2024, to provide sufficient time to migrate the traffic described above. All traffic must be moved by January 2, 2025. All ASRs for the Williamsburg NY C20 switch must carry the project code of NYCKNYBRDS0.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Bridge Street NY 5E switch.
