## Subject: Verizon Partner Solutions Industry Letter: Sayville NY DMS Switch Retirement

## **PLEASE NOTE:**

- All references to the Sayville NY DMS switch are associated with CLLI code SYVLNYSADS0 and will not be repeated throughout this letter.
- •All references to the Deerpark NY CS2k switch are associated with CLLI code DRPKNYDPPS0 and will not be repeated throughout this letter.

As set out in the Verizon New York Inc. Short Term Public Notice Under Rule 51.333(a), dated July 9, 2024, on or after October 1, 2024, the Sayville NY DMS switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

**General Information:** The Exchange Codes (NXXs) in Numbering Plan Area (NPA) 631 currently residing in the Sayville NY DMS switch (see list in Table B below) will be moved to the Deerpark NY CS2k switch (see details in Table A below).

The native NPA NXXs belonging to the Sayville NY DMS switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Deerpark NY CS2k switch. This will occur on or after October 1, 2024.

## **Network Changes and Trunk Rearrangements:**

The Deerpark NY CS2k switch will be the recipient office of traffic migrated from the Sayville NY DMS switch. Traffic bound for the codes listed in Table B will be delivered via the BRWDNYBWGT0 Deerpark DPG0T Tandem (DRPKNYDPG0T intralata SHA / DRPKNYDPG0T inter-lata FG Access SHA).

After all traffic is migrated off the Sayville NY DMS switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers, and paging carriers will need to secure new trunk groups built to the Deerpark NY CS2k switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the Sayville NY DMS switch will be required to reposition the codes to the Deerpark NY CS2k switch.

All ASRs for the Deerpark NY CS2k switch must be received no later than September 1, 2024, to provide sufficient time to migrate the traffic described above. All traffic must be moved by October 1, 2024. All ASRs for the Deerpark NY CS2k switch must carry the project code of SYVLNYSADS0.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Sayville NY DMS switch.
