## Subject : Verizon Partner Solutions Industry Letter: Collegeville PA 5ESS Switch Retirement

## **PLEASE NOTE:**

- All references to the Collegeville PA 5ESS switch are associated with CLLI code CGVLPACLDS0 and will not be repeated throughout this letter.
- •All references to the Fort Washington PA CS2K switch are associated with CLLI code FTWSPAFWPS1 and will not be repeated throughout this letter.

As set out in the Verizon Pennsylvania LLC Short Term Public Notice Under Rule 51.333(a), dated September 23, 2024, on or after February 1, 2025, the Collegeville PA 5ESS switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

**General Information:** The Exchange Codes (NXXs) in Numbering Plan Areas (NPAs) 484 and 610 currently residing in the Collegeville PA 5ESS switch (see list in Table B below) will be moved to the Fort Washington PA CS2K switch (see details in Table A below).

The six (6) native NPA NXXs belonging to the Collegeville PA 5ESS switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Fort Washington PA CS2K switch. This will occur on or after February 1, 2025.

## **Network Changes and Trunk Rearrangements:**

The Fort Washington PA CS2K switch will be the recipient office of traffic migrated from the Collegeville PA 5ESS switch. Traffic bound for the codes listed in Table B will be delivered via the Market 92T Tandem (PHLAPAMK92T).

After all traffic is migrated off the Collegeville PA 5ESS switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers, and paging carriers will need to secure new trunk groups built to the Fort Washington PA CS2K switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT)

with access connectivity in the Collegeville PA 5ESS switch will be required to reposition the codes to the Fort Washington PA CS2K switch.

All ASRs for the Fort Washington PA CS2K switch must be received no later than December 22, 2024, to provide sufficient time to migrate the traffic described above. All traffic must be moved by February 1, 2025. All ASRs for the Fort Washington PA CS2K switch must carry the project code of **CGVLPACLDS0**.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Collegeville PA 5ESS switch.
