PLEASE NOTE:

- All references to the Albany NY Ribbon Signal Transfer Point (STP) switch are associated with CLI code ALBYNYSS01W and will not be repeated throughout the notice.
- All references to the White Plains NY Oracle EAGLE STP switch are associated with CLI code WHPLNYWP09W and will not be repeated throughout the notice.
- All references to the Schenectady NY Ribbon STP switch are associated with CLI code SCHNNYSC01W and will not be repeated throughout this letter.
- All references to the Garden City NY Oral EAGLE STP switch are associated with CLI code GRCYNYGC85W and will not be repeated throughout this letter.

Description of the Planned Network Changes:

Verizon will make changes to its Signaling System 7 (SS7) network and services resulting from its consolidations plans. The Albany NY Ribbon STP, located at 158 State Street, Albany NY 12207, will be removed from service and the SS7 traffic will be moved to the White Plains NY Oracle EAGLE STP, located at 111 Main Street, White Plains, NY 10601. Also, the Schenectady NY Ribbon STP, located at 133 Clinton Street, Schenectady, NY 12305, will be removed from service and the SS7 traffic will be moved to the Garden City NY Oracle EAGLE STP, located at 741 Zeckendorf Boulevard, Garden City, NY 11530. All SS7 traffic to be migrated includes, but is not limited to InterLata (Access/FG/CLEC/IXC), wireless traffic and paging traffic.

Description of Reasonably Foreseeable Impact of the Planned Changes:

SS7 service providers with SS7 link terminations in Verizon's Albany NY and Schenectady NY Ribbon STPs will be contacted prior to the rehome to confirm creation of new link terminations in the White Plains NY and Garden City NY Oracle EAGLE STPs. While carriers will not have to submit Access Service Requests (ASRs) as the rehome will be completed using existing facilities to these offices, the following situations may require ASRs: 1) Carriers may need to add additional links to the White Plains NY and Garden City NY Oracle EAGLE STPs if their existing links cannot handle the added signaling from the rehome (this is unlikely for most, but if additional links are required, then the customer will be required to issue ASRs), and; 2) After the rehome is complete, carriers will be required to issue ASRs to disconnect their Albany NY and Schenectady NY Ribbon STP links to stop the billing.

SS7 service providers and any other affected carriers will need to alter their SS7 transport, OffNet services arrangements (services obtained from third parties) and/or Gateway services in order to access or continue serving customers served by offices that are currently homed to Albany NY and Schenectady NY Ribbon STPs.
