PLEASE NOTE:

- All references to the Delmar, NY 5ESS switch are associated with CLLI code DLMRNYDADS0 and will not be repeated throughout this notice.
- All references to the Albany, NY PEO switch are associated with CLLI code ALBYNYSSPS1 and will not be repeated throughout this notice.

Description of the Planned Network Change(s):

The Verizon Delmar, NY 5ESS switch, located at 328-334 Delaware Avenue, Delmar, NY 12054, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Albany, NY PEO switch, located at 158 State Street, Albany, NY 12207. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Albany, NY PEO switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Delmar, NY 5ESS switch will be required to reposition the codes to the Albany, NY PEO switch.

All ASRs for the Albany, NY PEO switch must be received no later than May 15, 2023 to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Delmar, NY 5ESS switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Delmar, NY 5ESS switch (**on or after July 3, 2023**). This will serve to guide interconnect re-routes of traffic for the three (3) native codes currently served by the Delmar, NY 5ESS switch to reflect the Albany, NY PEO switch as the new home switch. All ASRs for the Albany, NY PEO switch must carry the project code of DLMRNYDADS0.
