PLEASE NOTE:

- All references to the Seaside Park NJ DMS100 switch are associated with CLLI code LVLTNJSPDS5 and will not be repeated throughout this notice.
- All references to the New Brunswick NJ C20 switch are associated with CLLI code NBWKNJNBPS2 and will not be repeated throughout this notice.

Description of the Planned Network Change(s):

The Verizon Seaside Park NJ DMS100 switch, located at 1407 Grand Central Avenue, Seaside Park, NJ 08752, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon New Brunswick NJ C20 switch, located at 18 Paterson Street, New Brunswick, NJ 08901. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers and paging carriers will need to secure new trunk groups built to the New Brunswick NJ C20 switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Seaside Park NJ DMS100 switch will be required to reposition the codes to the New Brunswick NJ C20 switch.

All ASRs for the New Brunswick NJ C20 switch must be received no later than July 17, 2023 to provide sufficient time to

migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Seaside Park NJ DMS100 switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Seaside Park NJ DMS100 switch (**on or after September 1, 2023**). This will serve to guide interconnect re-routes of traffic for the three (3) native codes currently served by the Seaside Park NJ DMS100 switch to reflect the New Brunswick NJ C20 switch as the new home switch. All ASRs for the New Brunswick NJ C20 switch must carry the project code of **LVLTNJSPDS5**.
