PLEASE NOTE:

- All references to the Larchmont NY 5E switch are associated with CLLI code LRMTNYLADS0 and will not be repeated throughout this notice.

- All references to the Pleasantville NY DMS switch are associated with CLLI code PSVLNYPVPSA and will not be repeated throughout this notice.

Description of the Planned Network Change(s):

The Verizon Larchmont NY 5E switch, located at 5 Franklin Avenue, Larchmont, NY 10538, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Pleasantville NY DMS switch, located at 465 Marble Avenue, Pleasantville, NY 10570. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Pleasantville NY DMS switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Larchmont NY 5E switch will be required to reposition the codes to the Pleasantville NY DMS switch.

All ASRs for the Pleasantville NY DMS switch must be received no later than August 1, 2023 to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Larchmont NY 5E switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted; prior to decommissioning of the Larchmont NY 5E switch (**on or after October 2, 2023**). This will serve to guide interconnect re-routes of traffic for the three (3) native codes currently served by the Larchmont NY 5E switch to reflect the Pleasantville NY DMS switch as the new home switch. All ASRs for the Pleasantville NY DMS switch must carry the project code of **LRMTNYLADS0**.
