PLEASE NOTE:

- All references to the Richmondville NY DMS100 remote switch are associated with CLI code RCVLNYRHRS0 and will not be repeated throughout this notice.
- All references to the Richmondville NY T1000 remote packet switch are associated with RCVLNYRHRP0 and will not be repeated throughout this notice.
- All references to the Albany NY Packet End Office (PEO) switch are associated with CLI code ALBYNYSSPS0 and will not be repeated throughout this notice.

Description of the Planned Network Change(s):

The Verizon Richmondville NY DMS100 remote switch, located at 115 High Street, Richmondville, NY 12149, will be retired and removed from the network after all traffic served by this switch is migrated to the Richmondville NY T1000 remote packet switch, located at 115 High Street, Richmondville, NY 12149. All traffic to be migrated to the Richmondville T1000 remote switch will be homed to the Albany NY PEO switch. Traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Albany NY PEO switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Richmondville NY DMS100 remote switch will be required to reposition the codes to the Albany NY PEO switch.

All ASRs for the Albany NY PEO switch must be received no later than December 15, 2023 to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Richmondville NY DMS100 remote switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Richmondville NY DMS100 remote switch (**on or after January 2, 2024**). This will serve to guide interconnect re-routes of traffic for the one (1) native code currently served by the Richmondville NY DMS100 remote switch to reflect the Richmondville T1000 remote packet switch and the Albany NY PEO switch as the new home switch. All ASRs for the Albany NY PEO switch must carry the project code of RCVLNYRHRS0.
