PLEASE NOTE:

- All references to the Lawrence, MA 5ESS switch are associated with CLLI code LWRNMACADS2 and will not be repeated throughout this notice.
- All references to the Lowell, MA CS2K switch are associated with CLLI code LWLLMAAPPSA and will not be repeated throughout this notice.

Description of the Planned Network Change(s):

The Verizon Lawrence, MA 5ESS switch, located at 2 Hampshire Street, Lawrence, MA 01840, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Lowell, MA CS2K switch, located at 115 Appleton Street, Lowell, MA 01852. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Lowell, MA CS2K switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Lawrence, MA 5ESS switch will be required to reposition the codes to the Lowell, MA CS2K switch.

All ASRs for the Lowell, MA CS2K switch must be received no later than December 2, 2024, to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Lawrence, MA 5ESS switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Lawrence, MA 5ESS switch (**on or after February 1, 2025**). This will serve to guide interconnect re-routes of traffic for the twenty-six (26) native codes currently served by the Lawrence, MA 5ESS switch to reflect the Lowell, MA CS2K switch as the new home switch. All ASRs for the Lowell, MA CS2K switch must carry the project code of LWRNMACADS2.
