1. The purpose of this modification is to incorporate changes to Sections B, C, G, H and J that allow the GSA contracting officer (CO) to issue Delegations of Procurement Authority (DPA) to agency warranted COs and appoint them as Ordering Contracting Officers (OCO). The modification allows OCOs to issue task order solicitations that contain non-standard requirements, such as:
 - Agency Unique CLINs and prices that will not be incorporated into the Networx contract
 - End-to-end bundled unit pricing
 - Unit pricing that includes all applicable taxes, fees and surcharges
 - Taxes, fees and surcharges may be included in the calculation of the GMS fee and will be considered billed eligible revenue
 - Additional billing elements
 - Additional deliverables
